1. 2 years of training (Master 1 & Master 2) applied for three-year-graduates in economics, management, accounting, finance and relevant majors.
2. 1 year of training (Master 2) applied for four-year-graduates which is equivalent to BAC+4 following French education system.

Admission requirement

MASTER 1 Candidates graduated from colleges (3-year-training) of Vietnam or colleges equivalent to L3 level of French republic.

MASTER 2 Candidates graduated from Master 1 (French education system) or universities (4-year-training following Vietnamese education system) with certificate of joining Maste 1 Finance. Specific documentation will be considered by program director.

Moreover, candidates need to prove their level of English through the admission interview.

Positive result will be decided by the Admission Committee base on documentation and interview constructed in English langue.

➔ Tuition fee: ≈ 89 000 000 VND/ year (3 900 EUR/ year)
